It is a condition of such a licence that the performance of the equipment must meet the minimum licensing requirements specified in the Interface Requirement 2000.
- 3. The Wireless Telegraphy (Licence Charges) Regulations 2005 set out the fees for licences to use radio equipment issued under the Wireless Telegraphy Act.
- 4. The licence fee is £50 which includes the charge for registration of the first link for the first year of the licence. Please enclose the fee with your application and make cheques or postal orders payable to 'Ofcom'.
